How to Vote in Safe at Home

Who to Register with:

As a Safe at Home participant you will register to vote with the Secretary of State's Office, not your County Auditor. Please use your Safe at Home designated address for your mailing address and your actual residential address for your residential address on your voter registration form. This will ensure you receive the correct ballot.

What Forms to Fill Out:

Participants who wish to vote need to fill out:

- Voter Registration Form.
- Absentee Ballot Request Form (Annually-Expiring December 31st of every year).

When:

Voter Registration forms and Absentee Ballot Request forms can be submitted into our office at any time.

Important Notes:

- Voting at your polling place on Election Day is not a safe option for you. This will create a public record that requires the use of your actual residential address.
- Absentee Ballots need to be requested as early as possible before an election.
